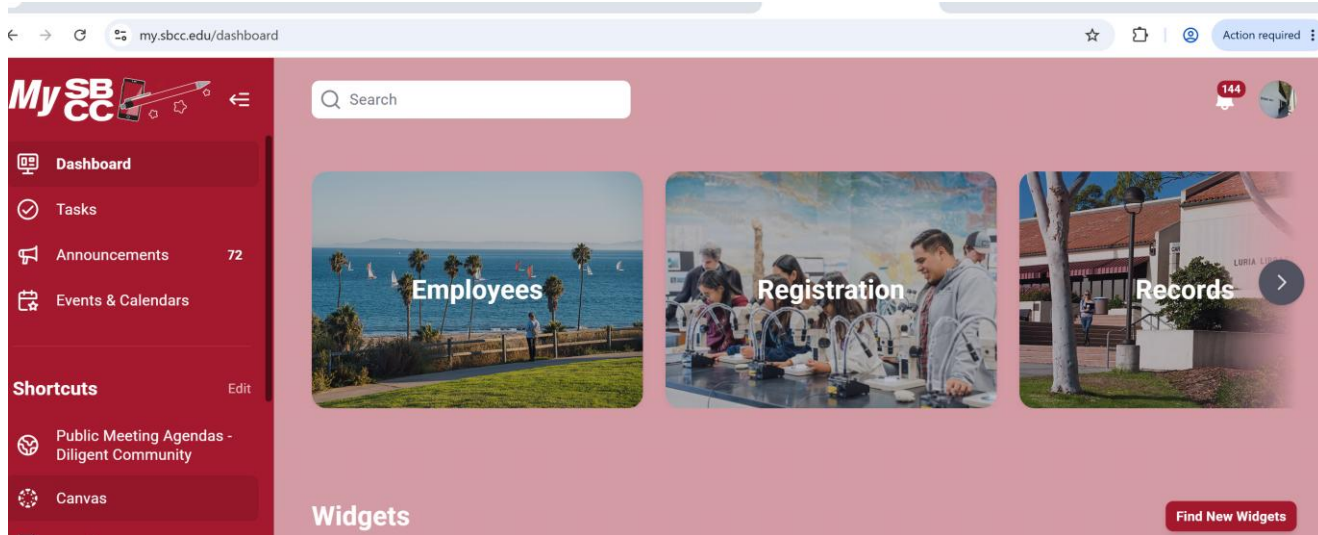

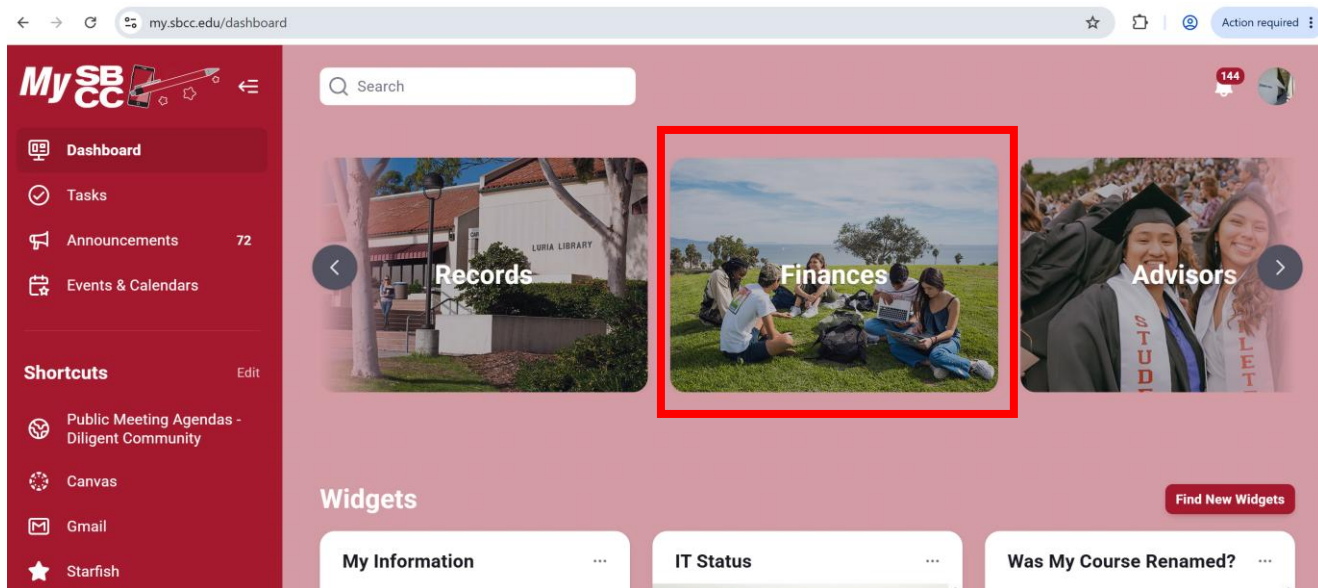

## Step 1. Log on to MySBCC

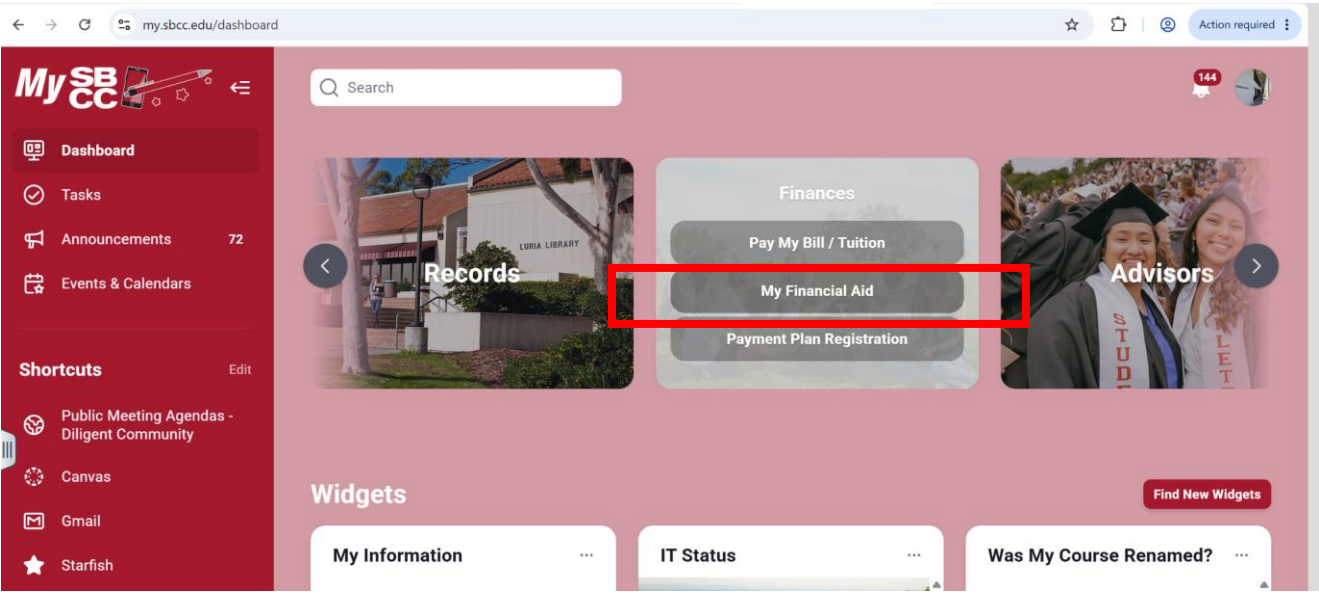

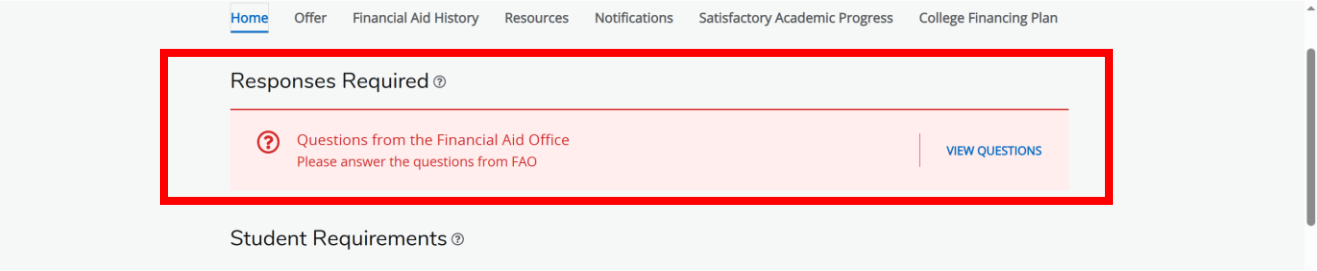
## Step 2. Hover over 'Finances'



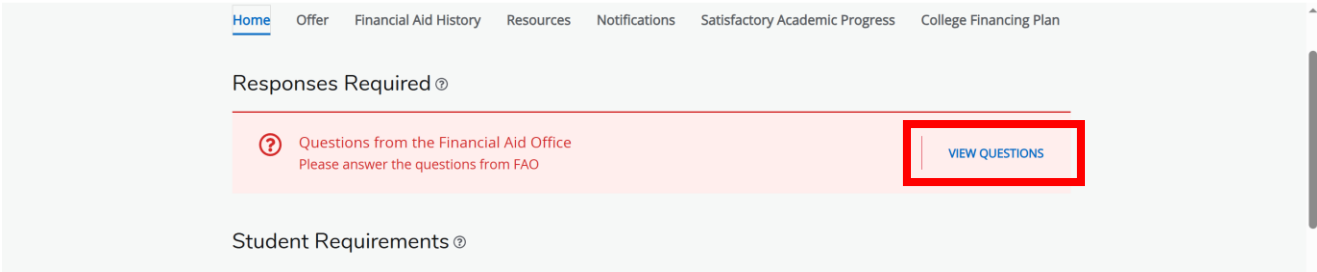
Step 3. Click on 'My Financial Aid'
